Compliance status

This website is partially compliant with the <u>Web Content Accessibility</u> <u>Guidelines version 2.1</u> AA standard, due to non-compliances listed below.

- Alt text not being available in two instances on the homepage
- Most text has good a contrast ratio, however there are a limited number of places where text on the website does not have a contrast ratio of 4.5:1
- Users can tab through most of the website without problems but cannot tab through the FAQS and Vacancies section easily.
- There are a limited number of places where increasing the size of text causes issues with overflow.

Non-accessible content

The content listed below is non-accessible for the following reasons:

Non-compliance with the accessibility regulations

- Criterion 1.1.1 Non-text Content
 - Not all images currently have Alt Text we will be working on this and aim to have all images updated with alternative text by the end of October 2020.

Disproportionate burden

Navigation and accessing information

There's no way to skip the repeated content in the page header (for example, a 'skip to main content' option).

It's not always possible to change the device orientation from horizontal to vertical without making it more difficult to view the content.

It's not possible for users to change text size without some of the content overlapping.

Some of the text does not meet the 4.5:1 contrast ratio.

Interactive tools and transactions

Some of our interactive forms are difficult to navigate using a keyboard.

We've assessed the cost of fixing the issues with navigation and accessing information, and with interactive tools and transactions. We believe that doing so now would be a <u>disproportionate burden</u> within the meaning of the accessibility regulations. We will make another assessment when the supplier contract is up for renewal, likely to be in March 2021.

Content that's not within the scope of the accessibility regulations

PDFs and other documents

The accessibility regulations <u>do not require us to fix PDFs or other</u> <u>documents published before 23 September 2018</u> if they're not essential to providing our services.

Any new PDFs or Word documents we publish will meet accessibility standards.

Live video

We currently have no live videos on the website and have no plans to use live videos on the website. If this changes we will meet the accessibility standards.

Preparation of this accessibility statement

This statement was prepared on 15th September 2020. It was last reviewed on 17th September 2020.

This website was last tested on 17th September 2020. The test was carried out internally by GMLPN.

We used this approach to deciding on a sample of pages to test which covered a range of the website template pages:

- The sample pages chosen have a range of the different, standard page templates that are available
- The check was carried out internally following the <u>basic check</u> <u>guidance published on gov.uk</u>
- This approach was taken to avoid putting a disproportion burden on the organisation in terms of monetary value and time resource
